The Notice of AGM along with the Annual Report was sent through email to the Members of the Company whose email addresses are registered with the Company / Depository Participant containing the detailed procedure to be followed by the Members who were desirous of casting their votes electronically as provided under Rule 20 read with amendments made thereto and notifications issued by the Ministry of Corporate Affairs ('MCA').
- 3.3. As prescribed in the Rules and General Circulars issued by the MCA, the Company has also published advertisements in newspapers and it carried all required information as specified in the said rules and notifications.
- 3.4. The Members of the Company as on the "Cut-off" date i.e. Monday, August 29, 2022 were entitled to vote on the businesses (item nos. 1 to 5) as set out in the Notice of the 40th AGM.
- 3.5. t It was announced to the members at the 40th AGM, held on Monday, September 5, 2022 through two-way Video Conference/ other audio-visual means, those who have not exercised their votes through remote e-Voting may, if they wish to, exercise their votes through electronic voting system being provided during the meeting.
- 3.6. The remote e-Voting commenced on Friday, September 2, 2022 (9.00 a.m. IST) and ended on Sunday, September 4, 2022 (5.00 p.m. IST) and the e-voting platform was blocked thereafter.
- 3.7. The votes cast through remote e-voting as well as e-voting at AGM were unblocked after completion of e-voting during the AGM in the presence of Sangeeta & Prathamesh who are not in the employment of the Company.
