#### Dear Sir,

1. I, Milind Nirkhe, Practicing Company Secretary, Membership No. FCS 4156/ C. P. No. 2312), have been appointed as the Scrutinizer, by the Board of Directors of Panama Petrochem Limited for the purpose of scrutinizing the remote e-Voting and voting through electronic voting system during the Annual General Meeting ('AGM') as per the provisions of Section 108 of the Companies Act, 2013 ('the Act') read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (Amendment Rule 2015) on the businesses contained in the Notice of the 39<sup>th</sup> AGM of the Equity Shareholders of the Company, held on, Monday September 6, 2021 through two-way Video Conferencing facility / other audio visual means.

- 2. The management of the Company is responsible to ensure the compliance with the requirements of the Act, Rules and notifications relating to voting through electronic means and SEBI Listing Regulations on the businesses set out in the Notice of the 39<sup>th</sup> Annual General Meeting of the Members of the Company. My responsibility as a Scrutinizer for the remote e-Voting and e-voting during the AGM is restricted in making a Scrutinizer's Report of the votes cast "IN FAVOUR" or "AGAINST" for the businesses set out in the Notice, based on the reports generated from the e-Voting system of Central Depository Services Limited ('CDSL'), the authorized agency to provide e-Voting facilities before and during the AGM, engaged by the Company.
- 3. Further to above, I submit my report as under:
- 3.1. The Company has provided the e-Voting facility through CDSL. Company had uploaded all the items of businesses to be transacted on the website of the Company and also on the website of CDSL to facilitate their Shareholders to cast their vote through e-Voting.
- 3.2. The Notice of AGM along with the Annual Report was sent through email to the Members of the Company whose email addresses are registered with the Company / Depository Participant containing the detailed procedure to be followed by the Members who were desirous of casting their votes electronically as provided under Rule 20 read with amendments made thereto and notifications issued by the Ministry of Corporate Affairs ('MCA').
- 3.3. As prescribed in the Rules and General Circulars issued by the MCA, the Company has also published advertisements in newspapers and it carried all required information as specified in the said rules and notifications.
- 3.4. The Members of the Company as on the "Cut-off" date i.e. Monday, August 30, 2021 were entitled to vote on the businesses (item nos. 1 to 4) as set out in the Notice of the 39<sup>th</sup> AGM.
- 3.5. The Chairman at the 39<sup>th</sup> AGM, held on Monday, September 6, 2021 through two-way Video Conference/ other audio-visual means announced that Members who

have not exercised their votes through remote e-Voting may, if they wish to, exercise their votes through electronic voting system being provided during the meeting.

- 3.6. The remote e-Voting commenced on Friday, September 3, 2021 (9.00 a.m. IST) and ended on Sunday, September 5, 2021 (5.00 p.m. IST) and the e-voting platform was blocked thereafter.
- 3.7. The votes cast through remote e-voting as well as e-voting at AGM were unblocked after completion of e-voting during the AGM in in the presence of Sangeeta & Prathamesh who are not in the employment of the Company.
